PRESIDENTIAL PRIMARY ELECTION

To the Qualified Electors of the Charter Township of Royal Oak, Oakland County, Michigan

NOTICE IS HEREBY GIVEN that any qualified elector of the Charter Township of Royal Oak who is not already registered, may register to vote at the office of the Township Clerk, the office of the County Clerk, a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at Michigan.gov/vote and mailed to the Township Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in person with the local clerk is **MONDAY, FEBRUARY 12, 2024.**

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the Township Hall Clerk's Office located at 21131 Gardenlane, 202, Ferndale, MI 48220-Room 202.

Regular business hours: Monday-Thursday from 9:00 a.m. – 4:00 p.m.

Saturday, February 24, 2024 from 8:00 a.m. – 5:00 p.m.

Election Day, February 27, 2024 from 7:00 a.m. – 8:00 p.m.

Sample Ballot can be viewed in the Clerk's Office voting for Democrat or Republican President only. Nothing else is on the ballot. Information can also be viewed under the Secretary of State Michigan Voters Information Center (MVIC).

Deadline for mailing absentee ballots is Friday, February 23, 2024, at 5:00 p.m.
A written request must be submitted to spoil ballot to reissue by February 16, 2024, at 4:00 p.m.
